#### March Break Reimbursement Fund

## Need support for your autistic child during March Break?

The March Break Reimbursement Fund is available to Ontario families of autistic children or youth who retain the services of a one-to-one support worker OR who have paid for their child to attend a March Break camp or program but not both.

Maximum reimbursements of \$350 per child or youth (up to 18th birthday) will be made to subsidize services purchased during the March Break Week.

A minimum of 1,007 families from across Ontario are expected to receive reimbursements. Reimbursements will be provided based on a random selection made from all eligible applicants who apply between December 20, 2023 and January 22, 2024.
