2.0 Action

2.1 Vice-Chair Schleifer took a vote by Association on the Special Education Plan for 2023-2024. All Associations present (Association for Bright Children, Centre for Diverse Learners-Halton, Community Living Burlington, Easter Seals Society), Members at Large (3) and Trustees Baxter and Brydon were in support of the plan. L. Goodrow emailed Community Living North Halton, Halton Down Syndrome and Voice and asked if they could please email her with their decision on their approval or not of the Special Education Plan 2022-2023 that was shared earlier this month to SEAC. Community Living North Halton replied to L. Goodrow that they do support the Special Education Plan 2022-2023. Halton Down Syndrome and Voice for Deaf and Hard of Hearing Children were not in attendance and have not responded to an email sent to them June 6 during the SEAC meeting.

2.2 A presentation was made by M. Bates, Manager, Mental Health, Student Well-Being Department. The presentation is linked here.

There was an opportunity for questions after the presentation. Chair Brindle asked what additional supports will be put in place as there will be no virtual environment going forward for students that have been virtual for about 3 years. M. Bates responded that the department has been working closely with all secondary schools to have supports in place. Superintendent Barnes also commented that there will be "well-being" check-ins. M. Somer wanted to know more about the depth of trauma training. M. Bates responded that the Well-Being Department has worked closely with schools and departments who are looking for more in depth training. K. Schleifer asked about the online survey, and was interested in the students that had barriers to the online process and were they also considered? If not, are you planning to include them in your research? M. Bates responded that absolutely every and all students had an opportunity to participate in a meaningful way. K. Schleifer thanked everyone for their presentation.

2.3 S. Marks, Principal, Special Education Services Department and S. Gardi, Instructional Program Leader presented on the Structured Learning Pilot Project. There was an opportunity for questions after

We are talking about a consultation process that will capture the voice of our students and families to arrive at a name that will work for everyone and we will look into this further next year.

4.0 Communication to SEAC

Superintendent's Report for June, 2023

1. Summer Learning - The Ministry has provided \$220 000 for summer learning and transitions. The budget emphasis will be on supporting transitions of students. Schools will be able to access central specialized supports from Special Education, Student Well-Being, Equity and Indigenous Education departments, as well as school-based staff, to comprehensively support students with special education needs, mental health needs or simply those returning to in-person learning.

In addition, we are supporting summer learning offerings through Gary Allan (Summer School gr 7-12) and School Programs (K-gr 6) with educational assistants to promote an inclusive model of summer learning for all students. SES will also be offering Assistive Technology camps and Structured Reading Intensive Program for students receiving IRT support.

- 2. ASSDP After School Skill Development Program for students with Autism is enveloped funding from the Ministry of Education to run in-year (after school) and summer sessions. The summer sessions will focus on Kindergarten / Grade 1 Entry to School skills small group one week sessions in each area of the board.
- 3. Special Athletes Track Meet: Schedule for June 16th at Garth Webb SS. We have over 450 students from elementary schools across HDSB and EC Drury School for the Deaf. It will be sure to be a great day!
- 4. Good-bye and a welcome Sadly, Sean Marks, Principal of Special Education, has come to the end of his 5-year term with the department. Sean has many accomplishments of which to be

Of note, he has been a driving force in the implementation of Structured Reading, the Structured Learning Class pilot and the vision for supporting students with autism that will unfold next year. Conan brings a wealth of knowledge and passion in supporting students with special education needs, as well as early literacy intervention.
