- 2.1 Budget Presentation Superintendent Negoi and J. Chanthavong, Controller of Financial Services presented the 2023-2024 Special Education draft budget update. - 2.2 Allocation of Educational Assistants (EAs) Sean Marks, Principal of Special Education Department presented on the allocation of educational assistants (EAs). Several members had questions after the presentation.
- 2.3 Special Education Plan (SPED) Superintendent Ruddock opened the floor to discuss any items that came from the draft SPED Plan. The plan will be voted on next month by SEAC. There were questions surrounding the self-contained class size cap, what is the Board's practice re supports for an IEP diagnosis, what is the process when a student with an existing IEP comes from another Board and would the Board consider specialized supports in the classroom for mental health for students.

Superintendent's Report for May, 2023

- 1. **Summer Learning** The Ministry recently announced through the budget process that funding for summer learning will continue again this year (and next). We are currently waiting on the technical papers to determine the parameters for spending these funds. We hope to have more information for the June SEAC meeting.
- 2. **Special Athletes Track Meet:** Planning is underway for our 36th Annual Special Athletes' Track Meet on June 16th. This is a highlight of the year for our students with special education needs. We will welcome over 430 students from Life Skills,

- Communication Programs, Mainstream classrooms, and EC Drury, both in-person at Garth Webb SS and virtually.
- 3. The <u>Director's Cut Episode #9 Mental Health & Well-Being</u> was released last week. This video highlights the supports offered by our Student Well-Being Department for elementary and secondary students. Michelle Bates, the Mental Health Lead, will be joining us next month to share more information about their work.

4.2 Association Reports

S. Lansley from Easter Seal Society reported the following:

National Accessibility Week will take place this year from May 28th to June 2nd. This is an annual event for Canadians to come together to celebrate the valuable contributions and leadership of Canadians with disabilities, highlight the work of individuals, organizations and communities who are removing barriers, and reflect on our ongoing efforts to become a better, more accessible, more disability inclusive Canada.

May 31st is Red Shirt Day[™] of Action for AccessAbility and Inclusion. This is a day when people across Canada come together and wear red in schools, workplaces and spaces everywhere in order to create a visible display of solidarity: to show their support for persons and families of those who are living with disabilities, celebrate the achievements of people living with disabilities, and to pledge their commitment to help create a fully accessible and inclusive society that honours and values the contributions of people of all abilities in all aspects of life in Canada.

A letter was sent to the directors of all school boards across Ontario by Easter Seals Ontario to formally invite boards to participate in both National Accessibility Week and Red Shirt Day.
