

Trustee Honoraria

Board Policy

Adopted: September 3, 2014

Review Date: October (annually)

1. Objective

The Halton District School Board shall pay to its elected Board members, a Trustee Honoraria in accordance with the Ontario Education Act, and related Ontario Regulations, specifically Ontario Regulation 357/06.

2. Policy Statement

For the term of office in respect of the period from December 1, 2014 or later, the Board will pay to a member an honorarium amount not to exceed the following amount:

- 100% of the maximum base amount as set out by regulation
- 100% of the maximum enrolment amount *
- 100% of the maximum allowable attendance amount**

The policy may be restricted by provincial regulation.

* The enrolment amount will be adjusted on an annual basis to reflect the prior year's Estimates ADE (Average Daily Enrolment) of the Halton District School Board (Appendix A).

** Per Appendix B of the Trustee Honoraria Policy and as aligned to regulation.

Appendix B

(effective December 1, 2014; revised June 2015, November 2019, October 2023)

Member Trustees will be entitled to the following: \$50.00 for attending any meeting of a committee of the Board that is required to be established by an Act or Regulation made under the Act. The attendance amount is payable for attendance at meetings including:

- Audit
- Parent Involvement
- Special Education Advisory
- Supervised Alternative Learning
- Student Discipline and Suspension/Expulsion Appeals

The attendance of alternates is not required, but rather discretionary. Alternates are not eligible for an attendance amount; however, where an alternate attends one of the aforementioned committees, in order to stand in for the member who is not in attendance, it is appropriate to pay the alternate the attendance amount.

Honoraria Claims

Claims for the Honoraria Attendance Amount will be submitted using the claim process provided by the HDSB. All trustee honoraria claims must be submitted to and approved by the appropriate Supervisor according to the following Approval Authority framework.
