



School Considerations

Tom Thomson PS:

- Decrease in capacity from 242 to 219.
 - Removed the stage from being counted as a classroom
- Classrooms are smaller in size compared with other schools.



Makenwdam PS

- Undersize gym
- Lack of speciality rooms (Science, Design and Tech, Arts, Music Instrumental)
- Originally designed as a K-6 school



Functional Building Capacity

(Portable Calculations)

Class size:

According to O.Reg., 132/12 *average class size* should not exceed:

- Kindergarten (Years 1 and 2) - 26 students per class
- Grades 1 to 3 - 20 students per class
- Grades 4 to 8 - 24.5 students per class

A classroom can hold 20-26 students in a school building.

Classroom	Building Capacity	Functional Capacity
JK-SK	26 students / classroom	26 students / classroom
Grades 1-3	23 students / classroom	20 students / classroom
Grades 4-8	23 students / classroom	24.5 students / classroom


Criteria to Evaluate Options

Criteria to review options include but not limited to:

Geographic Area and Barriers: <i>Can boundaries comprised of multiple Zones that are geographically contiguous be created, taking into account any physical barriers (natural or constructed)?</i>	Balance of Overall Enrolment: <i>Is student access to programs, resources, and extracurricular opportunities optimal? Is over and underutilization of buildings avoided to the extent possible, reducing where possible the use of portable classrooms in the short, medium and/or long-term?</i>
Viability of Programs: <i>Can the number of students required to offer and maintain a program in an educationally sound and fiscally responsible way be maintained?</i>	Stable Long-Term Boundaries: <i>Do the projections show long-term stability and result in avoiding the need for additional boundary changes in the short term?</i>
Student Experience: <i>Can the number of school moves students have experienced be minimized? Can cohorts/families be kept together? What strategies can be employed to improve the transition of students resulting from a boundary review process?</i>	Proximity to Schools: <i>Are there opportunities for maximizing walk-to schools, safe school routes, and incorporating natural boundaries into the proposed options? Can transportation requirements and costs be minimized?</i>
	Other: <i>Other criteria recommended by the BRSC or BRC</i>
