


# Scenario 7 → Oakville NE #2 ps is a single track ENG school, Oodenawi PS becomes single track ENG, Sunningdale PS FI boundary change, Post's Corners PS ENG boundary change

### Oakville NE #2 ps

- Opens 2019/2020 school year as a JK-7 ENG school; grade 8 ENG added 2020/2021
- ENG boundary is North Park/Dundas to the south, Burnhamthorpe to the north, Sixth Line/Neyagawa to the west, Eighth Line/Ward 7 eastern boundary to the east

## Munn's PS

FI boundary changes to include students north of Dundas to Burnhamthorpe between Sixth Line and Trafalgar and to students north of Burnhamthorpe between Sixth Line and Trafalgar

#### Oodenawi P

- ENG and FI boundaries change to exclude the area of new development north of North Park to Burnhamthorpe between Neyagawa and Sixth Line (to attend Oakville NE #2 ps/Sunningdale PS), the area south of Burnhamthorpe between Fourth Line and Neyagawa (to attend River Oaks PS/Sunningdale PS) and the area north of Burnhamthorpe between Neyagawa and Trafalgar (to attend River Oaks PS/Sunningdale PS)
- FI boundary changes to exclude the area south of Dundas to River Glen between Sixteen Mile Creek and Munn's Creek and exclude the area north of Dundas from Sixteen Mile Creek and Neyagawa (to attend Sunningdale PS)
- Starting 2019, FI program is removed by a grade starting with grade 2 FI; FI program is totally removed by 2025
  - o FI students in the area north of Dundas between Neyagawa/Fourth Line and Sixth Line and the area south of Dundas to River Glen between Sixteen Mile Creek and Munn's Creek go to Sunningdale PS
  - o FI students north of Dundas between Sixth Line and Eighth Line/Ward 7 eastern boundary go to Munn's PS

#### Post's Corners PS

- ENG boundary changes to exclude the area south of Dundas to gas pipeline between Munn's Creek and Sixth Line
- ENG boundary north of Dundas changes to include the area between Eighth Line/Ward 7 eastern boundary and Ninth Line

#### River Oaks PS

- ENG boundary changes to include the area south of Dundas to gas pipeline between Munn's Creek and Sixth Line
- ENG boundary north of Dundas changes to exclude the area between Sixth Line and Trafalgar (to attend Oakville NE #2 ps) and to include the area north of Burnhamthorpe between Neyagawa and Sixth Line and to include the area north of Burnhamthorpe between Sixth Line and Ward 7 eastern boundary (formerly at River Oaks PS) and the area south of Burnhamthorpe between Fourth Line and Neyagawa

#### Sunningdale PS

- FI boundary north of Dundas changes to include area between Sixteen Mile Creek and Sixth Line/Ward 7 eastern boundary
- FI boundary changes to include the area south of Dundas to River Glen between Sixteen Mile Creek and Munn's Creek and the area south of Burnhamthorpe between Fourth Line and Neyagawa
