- Oakville NE #3 PS opens Sept 2024 (K-7), Oakville NE #5 PS opens Sept 2025 (K-7);
 Gr8 added the following year
- Oakville NE #4 ps opens Sept 2030, Oakville NE #6 ps opens beyond the 2033/34 school year
- Students redirected from Dr. David R. Williams PS and Post's Corners PS to Palermo PS are placed back to their homes schools for 2024
- Any movement of students assumes Gr8 students remain at current location to graduate with their cohort
- Need to address the availability of space in existing French programs south of Dundas Street
 - no creation of new French programs
- Need to address overaccommodation pressures at Post's Corners PS (currently has the maximum of 12 portables)
 - boundary change required

Next Steps

Next meeting. To be a working meeting, discuss the options viability and possible changes.

Questions/Concerns

- Why is the HDSB still building a school size similar to ones with 24 portables on them.
 - Responded that we do not build for peak yield but for the sustainable yield of the school after the peak enrolment moves through. Otherwise the Board would have excess space that it would still need to spend resources on to operate, instead of investing in students.
- Concerns raised about the mental health of students following the pandemic, and to avoid disruptions where possible.
- Changing schools and the availability/losing a spot at child care centers and/or before and after care (at the end of meeting).
- BRC question regarding why Dr. David R. Williams has a max capacity listed at 18 portables when there are 24 there now.
 - The school is able to fit 24 portables on site but that number is not sustainable long term for the school and children.
- The numbers for Oakville #5 reflect the 6 classroom addition that is awaiting Ministry approval, if it is not approved the numbers for that building would drop to 788 pupil places.
- Why does Post's Corners PS numbers drop in option 1 and 2 in 2024?
 - Answer: in 2024 we made the assumption that all redirected students will be returning back to their home schools.
 - The boundary change for Post's Corners PS wont take place until Oakville #5 opens in those options.
