Previous Meeting Outcomes

The BRC review the menti results from the last meeting and their rankings of the options:

- Option 5 was kept.
- All other options were tabled.
- New variants of option 5 were to be created based on BRC discussion.

New Options

The new options are presented to the BRC.

- Option 5 Updates
 - Starting in Sept 2024, Grade 2-5 FI students directed to Forest Trail, Grade 6-8
 FI remains at Dr. David R. Williams (legacy exemption); school becomes a single
 track ENG school by the 2027/28 school year
 - Starting in Sept 2024, Zone ENG-H JK-5 ENG students directed to Oodenawi,
 Grade 6-8 ENG remains at Dr. David R. Williams (legacy exemption)
 - Starting in Sept 2025 (opening of Oakville NE #3), Zones ENG-AI and AH JK-5 ENG students directed to River Oaks, Grade 6-8 ENG remains at Post's Corners (legacy exemption)
- Option 6
 - Move Zone ENG-N from Oakville NE #5 to Dr. David R. WIlliams
 - Move Zones FI-N from Sunningdale to Forest Trail
- Option X1
 - Zone AH south created and moved to Post's Corners
- Option X2
 - Zone AH south created and moved to Post's Corners
 - Zone AE and AJ moved to River Oaks
- Option X3
 - Zone AH south created and moved to Post's Corners
 - Zone AE moved to River Oaks
- Option X4
 - Zones AH north and south remains at Post's Corners
 - Zones AE and AI moved to River Oaks
- Option X5
 - Zone AH south created and moved to Post's Corners
 - Zones AE and AI moved to River Oaks

Option Questions

- What option impacted the least amount of families?
- Are siblings exempt?
 - In these options, they are not grouped.
 - Implementation is not decided at this point of the review.

- Would the redirection continue into 2024?
 - Yes, redirections are reviewed annually. And is a separate process.
- If Oakville #3 is postponed. Are students not impacted by whatever option is approved?
 - The areas that are not impacted by the school and are able to be moved are moved. This will help alleviate some pressures at some of the schools.

Questions/Concerns

- How is the decision being made?
 - The BRC recommends 1 or 2 options. The BRSC takes their recommendation to the Senior Team, The Director then takes a recommendation to the Trustees for information then approval. The Trustees vote on the recommendation and it is then whatever is outlined in the approved board report is implemented.
- Has there ever been a time when the Trustees don't approve what is recommended?

- There have been times when the Trustees have asked for modifications and asked questions regarding what has been brought forward. It is rare that there would be a rejection of the proposed plan. But it can happen.
- Concern over there being multiple questions asking the same thing at the PIM.
- The possibility of having a parent representative to answer questions directed to the BRC at the PIM?
 - This could be included in the parents perspective, answering any of those types of questions.
- Concern over a loss of FI students if there are none in the north and will there be enough time for parents to choose FI.
 - o Applications can be removed but we will take this back and find what the date is.
