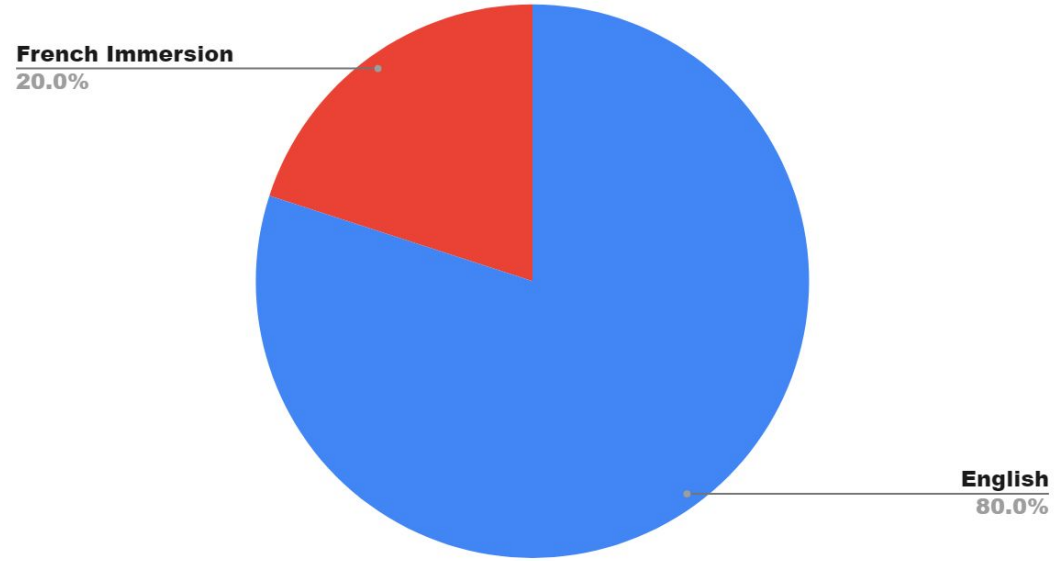

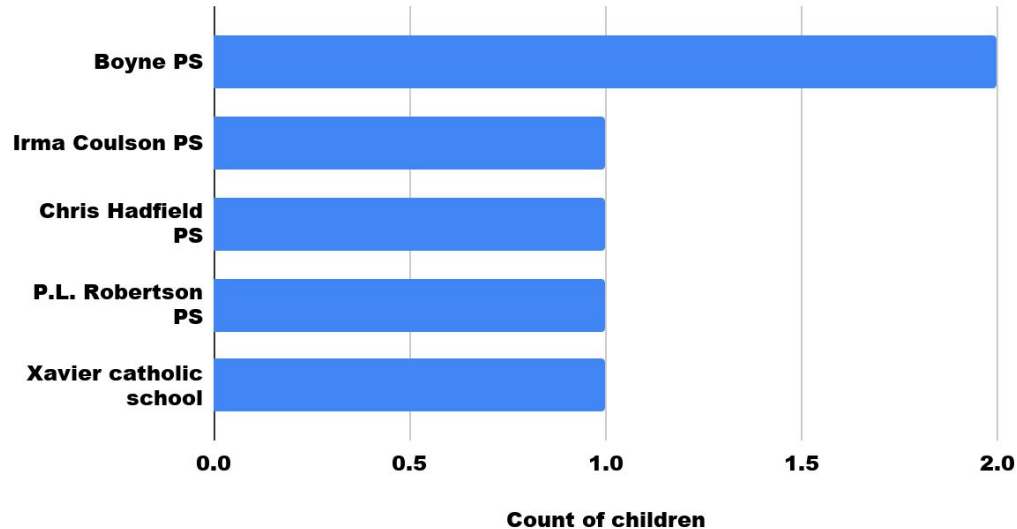

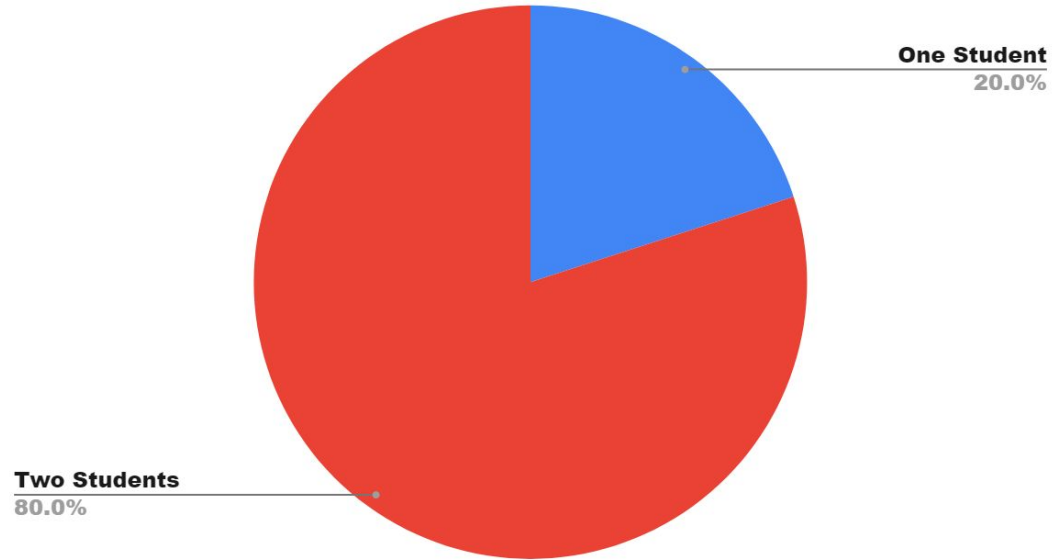

 - a. **Response:** “I am very grateful that the board is re-considering boundaries for schools. We had been looking for a proper channel to reach out to the school board.”

2. **Question:** Please suggest any considerations or additional option(s) for the Boundary Review Steering Committee to review.
 - a. **Response:** “Please evaluate my residential address school boundary. Viola Desmond Public School is 600m walking distance from my home. Instead we have to send our children to Boyne Public School which is 1.5 KM and we are also no eligible for bus transport. Please review this boundary.”

3. **Question:** Is there anything else you would like the Boundary Review Steering Committee to consider when evaluating the proposed option?
 - a. **Response:** “Use distance from home, age demographics and population density per age group while deciding boundaries.”
